## Items:

- 1. July 9 Minutes
  - Bill motioned to accept minutes; David seconded; Motion approved
- 2. Community Solar Partnership Update
  - progress report (Bill & John)
    - Lots of potential; recent check of ~\$2670; ~15 businesses signed up with a goal of 60 by the end of September; John needs introductions to potential businesses from BOD members as "cold calls" are tough; Bill will ask Jon/Craig for a spreadsheet that reflects business sign-ups and deposits to us (John prefers a spreadsheet as close to real-time as possible with business sign-ups)
- 3. Membership Benefits Update (Bill, John, Mik, Lucinda)
  - 3 new businesses signed up this past month; several others have indicated interest
  - Welcome Bag coming together; John showed the BOD the design; need more businesses to supply goodies to the bag; bag will have revolving goodies as are available from interested businesses
- 4. Greenfield Showcase Update (Mik, Sharon, Lisa, Rachel)
  - Alcohol Licensing is making us need to change our game plan; still working on securing music; Rachel working with Health Dept, DPW, and Licensing to cover all necessary bases
- 5. Finance Update (Rachel)
  - Finance Committee to meet with FCCC Executive Board today; brief meeting after our BOD to discuss
  - No financial statements from the FCCC or Thea since February 2019; running blind
- 6. Holiday Ornament Update (Rachel)
  - Positively Greenfield has agreed to collaborate on the ornament (for us to use their logo and link to them)
  - Displayed two potential layouts for discussion; group decided on close-up of Garden; maybe add old marque but play with placement; Positively Greenfield lettering needs to more clear
  - George is pleased to be the focus of the ornament but doesn't want it to be a Garden fundraiser
- 7. Holiday Lights Update (Rachel)
  - Committee decided on a new design for the lightposts simpler, winter-focused
  - Rachel met with Nan to discuss potential design; asked for design to share with BOD asap; will try to use the greenery and lights from previous post design; asked for a three-year contract broken into two possible forms: adding new design all at once (80 posts) or over the next three years (40, 20, 20)
  - MJ shared that the town is discussing a lighting project for Main St; she has a meeting with the Mayor soon to discuss

- Rachel also shared the Committee is working on potential lighting of trees on the Common; DPW contacted; upcoming meeting with Mayor

  - Waiting on a coding project
- 9. George Gohl
  - "retirement" from GBA acknowledgement plaque update (John)
    - Didn't discuss
- 10. New Business
  - Bill asked if we have enough candles for Jingle Fest; Rachel will check and get back to him
  - Rachel shared the "It's a Great Pumpkin Contest" addition to Halloween activities
  - Bill asked we get the Holiday Lights sponsorship letter together as soon as possible
